In accordance with Rule 343 paragraph 2. USB must have Competitor's name, Member's name and the exact running time of the Music (not skating time) including any starting signal and must be submitted at the time of registration.

Each Competitor must have an own back-up drive (USB Stick) in the format of a MP3, M4A or WAV format.
